LEGAL DESCRIPTION 10 FOOT UTILITY EASEMENT

The following describes a ten (10) foot utility easement situate within the Northeast One-quarter (NE1/4) of the Northeast One-quarter (NE1/4) of Section 30, Township 14 North, Range 5 East, Salt Lake Meridian, County of Rich, State of Utah; lying five (5) feet on each side of and parallel with the following described center line:

COMMENCING at the southeast corner of the Northeast One-quarter (NE1/4) of the Northeast One-quarter (NE1/4) of Section 30, Township 14 North, Range 5 East, Salt Lake Meridian; said corner being a U.S.D.A. Forest Service aluminum cap monument, and running thence along the southerly line of said Northeast One-quarter (NE1/4) of the Northeast One-quarter (NE1/4) of Section 30 North 87°37'31" West, a distance of 457.66 feet to the TRUE POINT OF BEGINNING;

Thence along the following nine (9) courses:

North 40°29'47" East, a distance of 163.59 feet;

North 39°20'20" East, a distance of 104.21 feet;

North 42°31'26" East, a distance of 74.82 feet:

North 40°06'12" East, a distance of 124.36 feet:

North 40°34'15" West, a distance of 114.54 feet:

North 42°55'23" West, a distance of 85.67 feet;

North 58°55'02" East, a distance of 63.96 feet;

North 49°09'04" East, a distance of 38.82 feet;

North 44°41'08" West, a distance of 73.10 feet and the POINT OF TERMINATION; from which the Northeast corner for Section 30, Township 14 North, Range 5 East, Salt Lake Meridian, bears North 22°34'17" East, a distance of 743.68 feet.

The sidelines of the above described easement shall be extended or shortened, as the case may be, so as to beginning on the southerly line of said Northeast One-quarter (NE1/4) of the Northeast One-quarter (NE1/4) of Section 30, Township 14 North, Range 5 East, Salt Lake Meridian.


