In the event work is commenced under this Permit and the permittee fails or refuses to complete the work, UDOT may, at its election, correct any deficiencies or otherwise complete the permitted work at the expense of the permittee. Upon receipt of an invoice of the costs incurred by UDOT, permittee shall immediately pay the amount due. If an action is required to be filed in court to collect the amount due, permittee shall be liable for UDOT's costs and fees, including attorney's fees.

Before work permitted is commenced, the permittee shall notify the permits inspector listed below. By applying for the Permit and UDOT issuing the Permit, permittee will comply with all instructions, conditions, requirements, and regulations of UDOT with respect to performance of the work described in the Permit. Permittee will properly control and warn the public of said work within UDOT's rights-of-way to prevent any accidents. Permittee shall defend, indemnify, and hold harmless UDOT from all damages or claims, including attorneys fees, arising out of any and all actions performed under this Permit by permittee, permittee's employees, agents or contractors, including failure to comply with terms and conditions in this Permit. Permittee shall pay for UDOT's inspections fees.

Permittee shall execute a bond in the minimum amount of \$100,000.00, as determined by the Regional Director/District Engineer, to insure faithful performance of the permittee's obligation. The bond shall remain in force for three years after completion of work.

Permittee shall not perform any work on state highway rights-of-way beyond those areas of operation described on this Permit.

If permittee fails to comply with UDOT's regulations, specifications, or instructions pertinent to this Permit, the Region Director/District Engineer or his duly authorized representative, may by verbal order, suspend the work until the violation is corrected. If permittee fails or refuses to promptly comply, the Region Director/District Engineer or his authorized representative may issue a written order stopping all or any part of the work. When satisfactory corrective action is taken, an order permitting resumption of work may be issued.

Special Limitations:

- Anyone working in UDOT's right of way must produce a valid permit, must be covered by a bond and insurance and must provide 24/7 contact phone numbers for emergencies
- Contractors working in UDOT's right-of-way must maintain access to transit facilities. Contractor shall notify UTA of all bus stops within work zone at least 1 business day prior to placing traffic control. Contractor shall keep access to bus stops for both passengers and buses, or provide an alternative approved by UTA. Both preserved and alternate access must match existing conditions or meet ADA standards.  - Licensee must place material such as road base, slag, gravel, etc. a minimum of 6" thick between edge of pavement and property line to prevent tracking onto the highway.
 - ATSSA Certified Traffic Control Maintainer required.
 - Licensee must comply with all environmental issues to include cultural & paleontologist clearances (see attachment "F").
 - Untreated Base Course with 97% compaction for the full depth of the trench with 6" lifts.
 - Must use state approved mix. Saw cut and tack joints. Replace asphalt to existing depth or 7". Place using multiple, uniform lifts.
 - When a hazard is within the work clear zone and the vertical grade separation is 6" or greater or a slope steeper than 4:1, a UDOT approved barrier system is required.
 - An inspector is required at the contractors expense with 48 hours notice.
 - Inspections are not free. Please call your inspector if you are not working. You will be billed for the inspection if you fail to call.
 - An inspector may be required at permittee's expense, with 48 hours notice. By accepting this permit, I agree to pay for inspection fees.
 - Licensee is responsible for repairing and/or restoring any portion of the roadway damaged during construction.
 - Licensee must restore shoulder of highway to its original or better condition. Including reseeded, replacing sidewalk, fencing, pipe, culverts or signs removed or damaged during construction and any other roadway features.
 - Place pavement marking materials with a UDOT approved material within 48 hours of completion of paving. The pavement marking materials must meet UDOT standard specifications for a minimum of 6 months from time of placement.
 - Work is to begin after 9:00 AM, open to traffic by 3:30 PM.
 - All work must be completed by 12:00 PM prior to any Holiday and shall not commence until 8:00 AM on the following work day.
 - Licensee shall keep highway free of mud and debris. A sweeper broom must be accessible for cleaning purposes.
 - The depth of bury for all utility facilities under pavement shall be a minimum of four (4) feet below the top of pavement or existing grade including open drainage features. Where utility facilities are installed within 20 feet from the edge of pavement, the depth of bury shall be a minimum of five (5) feet below top of grade so as to allow for installation of UDOT signs or delineators. Utility facilities under sidewalks shall be installed a minimum of three (3) feet below the top of sidewalk.
 - No storage of backfill material or pipe will be allowed within the ASHTO Clear Zone. Excavations must be backfilled daily or barrier will be required.
 - UDOT will not be responsible for any damages that may occur to this special encroachment, whether it be by vandals, routine highway maintenance, construction projects, etc.
 - Sidewalk shall be restored within 48 hours.
 - A copy of the permit must be present at the encroachment site for the entire encroachment period.
- Contractor will protect the I-15 ROW fence. No cutting of fence allowed.

Dear Permit Applicant:

UTAH DEPARTMENT OF TRANSPORTATION PERMIT

1. If a suspected hazardous materials, underground tanks, threatened or endangered species, historic, archeological or paleontological (fossil) item, feature or site is encountered, the construction operation of the permittee shall immediately stop in the vicinity of the discovery.
2. The UDOT region permits officer will be verbally notified by the permittee of the nature and exact location of the findings.
3. The UDOT region permits officer will keep the permittee informed concerning the status of the temporary restriction.
4. Failure to restrict construction and/or notify the UDOT region permits officer may result in revoking the permit and/or the conviction of a Class B Misdemeanor under UCA 9-8-404.
