Dear Mr. Hunsaker:

Reference is made to your request to construct a new lateral at the location identified above. A new 144-strand fiber will be pulled in one new 1.25 inch HDPE duct. Construction will include one under-track bore. The total length of the underground lateral on UP right of way is 60 feet.

As you will notice, the enclosed approved plans have been stamped with today's date. Please ensure that your inspectors, contractors, and other project employees are furnished with and use copies of the dated plans. Please note additional comments and sheets added to the original plan submittal.

It may be necessary during construction to produce a copy of this approval letter as permit.

Prior to any construction activity on Railroad property, it will be necessary for the following procedures to be completed in numerical order:

1. An agreement will need to be executed for the new installation. Mike Wallman will handle this agreement and issue the Notice to Proceed. He can be reached at 402-544-0577.
2. **You will need to contact Clarence Styvar**, our Engineering Construction Coordinator, to arrange for safety training and protection as required, for your construction operations. The starting date of construction is dependent on scheduling with him. He will notify the local Service Unit of the project specifics. To contact him, please call him on his cell phone: **(402) 203-8732**. Note: An American Fork City representative (other than the construction contractor) will need to be on site during construction.
3. Phone Union Pacific's **"Call Before You Dig"** at **800-336-9193**, to arrange for locates of other fiber optic facilities that may be located in the area of your project. This number must be called at least 48 hours in advance of any construction activity.

Please ensure that American Fork City employees and contractors are furnished only copies of the stamped approved plans for use on the site. The use of any other plans can result in shutting down the project until approved plans are secured.

Please forward a complete set of revised As Built plans to:

These plans must include Union Pacific Engineering Chainage Stations (ECS), distances from the track centerline at all running line change points (PI's), and any changes from the original approved plans.

These plans are valid for one calendar year; if the project has not started by one year from today, the plans will need to be resubmitted. If you have questions or comments regarding these plans, please contact Gary Voogd, of my staff, at 402-544-7425.
