Please use this letter as authorization for the limited purpose of allowing Global Capacity Group or its designated agent(s) to cross-connect Global Capacity Group's third-party provided service to the Zayo facilities identified below in conjunction with Service provided by Zayo to Global Capacity Group ("Service") pursuant to the Agreement for such Service between Zayo and Global Capacity Group ("Agreement"). This LOA does not obligate Zayo to pay any fees or charges associated with such cross-connect services.

This LOA terminates (i) 60 calendar days from today's date if not used, (ii) upon notification to Global Capacity Group or its designated agent(s) by Zayo, (iii) on the date that the circuit that is installed using this LOA is disconnected from Global Capacity Group's network or (iv) upon material breach of the Agreement, whichever is earlier. This LOA is not re-usable by Global Capacity Group, or its designated agent(s), for subsequent orders.

Global Capacity Group is authorized to remove red jumpers to complete connection to Zayo CFA. Global Capacity Group is not authorized to remove or modify any existing cross-connects, fiber patches, panel positions, cable, bulkheads or any other item without Zayo authorization. Customer agrees to indemnify and hold Zayo harmless against any loss, damage, cost or expense due to claims from third parties arising out of Customer's work under this LOA. Furthermore, this LOA does not alter or modify the use, provisioning, or delivery of Services, all of which remain governed by the Agreement(s) between Zayo and Global Capacity Group and any associated Customer Orders.
