- Proof of comprehensive general liability insurance in an amount of not less than one million (\$1,000,000.00) dollars for any one occurrence and two million dollars (\$2,000,000.00) aggregate.

## **Permit Terms:**

- Contractor shall guarantee work for one (1) year after the date of final approval by the City and termination of permit.
- For the duration of the work the permittee shall have an approved copy of the permit, traffic control plan, and city approved drawings at the work site at all times.
- All damage to city property shall be repaired prior to the issuing of other permits or authorization for any construction involving city property

## **Lindon City Excavation / Boring Requirements**

- Asphalt must be cut and restored within ten (10) working days.
- Must pothole all utilities. Core drilling is required. Call for inspection of any bore crossings city utilities.
- Must use flowable fill to backfill holes and use the Utilibond process to seal core drilled holes.
- We prefer no boring under sidewalk. If boring takes place under sidewalk the entire section of sidewalk that has been potholed will be replaced by contractor.
- Must stay within 24" 36" deep or Lindon City requires a utility profile.
